Dear Members,

Sub:- Rs. 5 Lakhs Equipment grant from Sports Authority of India under Khelo India Programme for the Intermediate Performing Centres (Districts).

Ref:- Our Circular No: 114 dated 12th April 200 and Circular No: 189 dated 30th May20.

We are happy to inform all our State/UT associations that Sports Authority of India, New Delhi indicated their approval in principle for release of Rs. 5 Lakhs per IPC for 50 selected Districts as per list enclosed as Annexure I subject to the following conditions:-

- 1. The official letter of sanction will be released after the re affiliation of Fencing Association of India is done by Ministry of Youth Affairs and Sports, GOI, New Delhi due to court orders with regard to 55 NSFs.
- 2. Each unit where your state association has recommended and now short listed as per the attachment should satisfy the following criteria:
 - a) The district unit / Centre / club should confirm that it has a minimum 30 regular Fencing Trainees. The coach should give coaching for at least 20 hours per week.
 - b) The district / unit would have to arrange suitable sports field/facilities for imparting coaching to trainees. Such Sports field / facilities owned by the proponent or arranged by arrangement with the State / Central Government or its entities, local bodies, clubs, educational institutions etc.
 - c) Information of the trainees with Aadhar Card Numbers and educational institution would have to be submitted for claiming the second installment of the grant in the first year, and thereafter, for all installments from second year onwards.
 - d) The District centre/unit should engage the services of past Champion Fencer if available. If not available, a coach of similar or near equivalent caliber and capacity needs to be engaged.
- 3. Grant is of Rs.5 lakhs per IPC as Fencing is identified as one of the 14 identified sports of Excellence in Olympics. Support will be provided towards remuneration to Coach/past champion athlete, support staff, purchase of sports equipment, sports kit, consumables, competition/event participation etc.Maximum remuneration permitted per past champion athlete would be INR 3 lakhs per year. The District/Unit has the choice to claim under some or all or any of the items as above to the extent of eligibility preferably for Equipment.

- 4. District centres which have been promoting sports for at least 5 years would be eligible to apply for support under the component except those in UTS of J&K, Ladakh, Daman & Diu, Andaman & Nicobar Islands, Lakshadweep and North eastern States which are exempted from the pre-qualification of sports promotion of at least 5 years.
- 5. One time initial grant of Rs.5 lakhs will be provided for preparation/up gradation of sports fileds, purchase of sports equipment, sports kits etc for the new District Centres out of these IPCs.
- 6. We are enclosing a format as Annexure I-B to verify the fulfillment of the above criteria in respect of the districts recommended by you and initially selected for assistance as per Annexure I.
- 7. You may examine whether the districts now listed under Annexure I pertaining to your State/UT satisfy these eligibility criteria. If any district/centre is not satisfying the criteria and if any other district in your state is satisfying the same criteria you may recommend that district which satisfies the criteria in place of the originally recommended district.
- 8. We should receive the above annexure I-B duly filled with copies of certificates on or before 5 pm of 10th August 2020.
- 9. The official sanction will be conveyed by Sports Authority as soon we secure re-affiliation from the Ministry in view of the recent Court orders on 55 Sports Organizations disaffiliating till all requisite information is loaded on the website of each NSF or court order received advising the Government for re affiliation.
- 10. We are making our sincere efforts to get the entire information as is mandatory to be up loaded on our website and approach the Govt to continue our affiliation with them.
- 11. Let us all be in readiness so that you can get the grant by way of equipment etc as described earlier in this communication at the earliest without further delay.
