## MEMORANDUM OF ASSOCIATION

### (Registration under Societies Registration Act XXI of 1860)

1. The name of the Society : Assam Fencing Association
2. The office of the Association is situated at R.G. Barua Road, Rodali Path, House No. 12, Guwahati-24 under Kamrup (M) District, Assam
3. The Objects of the Association : The objects of the Association are as mentioned below:
  - (i) To organize, encourage, promote and control Fencing Sports in Assam
  - (ii) To provide facilities for training in Fencing Sports and render financial assistance to individuals and organizations for the promotion of such work.
  - (iii) To diffuse useful knowledge and technique in Fencing by publishing literature in any form as it deems proper or by arranging meet in various parts of the country and participating meets abroad.
  - (iv) To ensure that all contests open to the members shall be organized under the rules of the Association.
  - (v) To frame rules and regulations in accordance with the rules of FAI (Fencing Association of India) for the conduct of national championship.
  - (vi) To make efforts to get affiliation with FAI, AOA, and other sports organizations.
  - (vii) To decide any dispute that may arise within an affiliated organisation or between members organisation, which may be referred to do it.
  - (viii) To recognize all such suspension.
  - (ix) To select and ensure representations for Fencing and team for National Championship contests or games.

## COPY OF BYE-LAWS

### ASSAM FENCING ASSOCIATION RULES AND REGULATIONS :

1. **DEFINITIONS** : In these rules :
  - (a) Association means A.F.A.
  - (b) General Council means the General Body of the members of the A.F.A.
  - (c) Managing Committee, means the body which according to the procedure mentioned hereunder shall exercise full powers on behalf of the Association.
  
2. **ADDRESS** : The address of the Registered office of the Association for the time being at at R.G. Barua Road, Rodali Path, House No. 12, Guwahati-24 or such other place as may be decided by the Managing Committee from time to time.
  
3. **Date of Formation** : The date of formation of the Association is 24 Oct., 1997
  
4. The Association is situated within the jurisdiction of the Registrar of Societies, Kamrup District.
  
5. **OFFICE HOURS** : The Office Hours of the Association shall be from 09.00 hours to 17.00 hours with one hour break
  
6. **THE OBJECTS OF THE ASSOCIATION ARE AS UNDER** :
  - (i) To organize, encourage, promote and control Fencing Sports in Assam.
  - (ii) To provide facilities for training in Fencing Sports and render financial assistance to individuals and organisations for the promotion of such training.
  - (iii) To diffuse useful knowledge and technique in Fencing by publishing literature in any form as it deems proper or by arranging meets in various parts of the country and participating in meets abroad.

- (iv) To ensure that all contests open to the members shall be organized under the rules of the Association.
- (v) To frame rules and regulations in accordance with the rules of F.A.I. for the conduct of National Championships.
- (vi) To make efforts to get affiliation with F.A.I. and Assam Olympic Association (A.O.A.) other concerned sports organizations and to maintain with other bodies as decided by the Association from time to time and adopt, maintain and enforce its Amateur (definition) and follow its rules and regulations.

**FUNDS / ACCOUNTS OF THE ASSOCIATION :**

- a) The financial year of the Association shall be from 1<sup>st</sup> April to 31<sup>st</sup> March.
  - b) The fund received on behalf of the Association shall be deposited in the account of the Association to be opened in a Scheduled Bank, Banking account shall be operated jointly by two among President or Hony. Secretary and Hony. Treasurer.
  - c) All expenses incurred in excess of the budget of on items not included in the budget passed shall have to be passed at the next meeting of the General Council.
15. **GENERAL COUNCIL** : The General Council of the Association shall consists of President and two representatives of each member organisation. The other office bearers shall continue to represent the member organisation, they belong. The president need not be a representative of any member organisation.
16. **OFFICE BEARERS** : (i) The President – One, (ii) Working President - One, (iii) Sr. Vice-President- Four, (iv) Vice President- Five (v) General Secretary- One, (vi) Joint Secretaries- Three, (vii) Asst. Secretary- Six, (viii) Organising Secretary- One, (ix) Hony. Treasurer – One, (x) Technical Director- Two (xi) Executive Member – Six.

**17. POWER AND FUNCTIONS OF THE GENERAL COUNCIL :** The Power the functions of the General Council shall be :

- (i) To formulate the policy of the Association and the principles on which it shall be carried out.
- (ii) To elect the office bearers and the Executive Committee Members for a period of four years.
- (iii) To impose and enforce penalties for any violation of the rules and the Bye-Laws of the Association.
- (iv) To realize the dues and control the funds of the Association and expand the same.
- (v) To call regular and special meetings of the General Council and fixed the date and place for holding all such meetings.
- (vii) To estimate the budget of the Association.
- (viii) To appoint sub-committees, Technical Committees, Information Committee, Medical Committee Officials, Disciplinary Action Committee and Selection Committee.
- (ix) To recognised and register the National Records.
- (x) To amend the constitution and the rules and regulations when considered necessary.
- (xi) To grant affiliation to new member organizations.
- (xii) To maintain register of approved officials.
- (xiii) To raise funds of the Association and administer the same.
