- Every member of the State Association / UT who is in good standing in accordance with the Clause - 8 of Memorandum of Association and Byelaws of Fencing Association of India, enlisted in the Electoral College to participate in the elections. State Fencing Association-02 (Two); Union Territory-02 (Two) representative each shall be entitled.
