Scrutiny of the nominations has been taken-up as per schedule on 12.08.2021. Findings are as under:

Disgualified Candidate:

During the scrutiny it has been indicated from the nomination papers that the necessary NOC has not been obtained by **Mr. Rashid Ahmed Chaudhary** before submitting the nomination papers for the post of 'Executive Member' of Fencing Association of India.

The record shows that Mr. Rashid Ahmed Chaudhary is a J&K State Govt. employee and therefore according to the section 8(vii) of Constitution of Fencing Association of India, NOC is required. The said section reads as under: -

"8(vii) Notwithstanding the restrictions as set out in 8.e (v) and (vi) above, civil servants are eligible for the post of President, Secretary General and the Treasurer and for becoming members of the Executive Committee, provided however they furnish a NOC from their employers, as per National Sports Development Code, MYAS (GOI)."

In view of the aforesaid statutory condition of obtaining NOC nomination paper of Mr. Rashid Ahmed Choudhary is rejected.
