Sub: Report of the election of Fencing Association of India (FAI) held on 18th September, 2022 for the posts of President and one EB Member.

Respected Madam,

Fencing Association of India (FAI) conducted a Special General Body Meeting (SGM) on 18.9.2022 at New Delhi in which the election to the vacant post of President and one EB Member for the balance period 2021-25 was one of the agenda. The election of FAI for the term 2021-25 was held on 20.8.2021 and the same has already been accepted by the ministry. The Election to the post of President and one Executive Body Member for the remaining period of 2021-25 term was necessitated due to the vacancy occurred due to resignation of the President and one post of EB member which remained unfilled in the previous election. The SGM was held at Hotel Suryaa, New Delhi at 11.00 hrs on 18.9.2021.

- 2. FAI requested Justice P.N Ravindran, Former Judge of Kerala High Court to be the Returning Officer to conduct the elections to which he agreed. Accordingly, FAI appointed him as the RO to conduct the elections..
- 3. Fencing Association of India had informed the ministry about holding of its SGM and had requested the ministry to send its observer.
- 4. The Indian Olympic Association nominated Shri M.S.Tyagi, Secretary General, Kho-Kho Federation of india as its Observer for the elections.
- 5. Justice (Retired) P.N Ravindran conducted the elections as per the procedure laid down in the model election guidelines of NSDCI, 2011 and the MoA of FAI. The entire activity relating to the election of FAI was uploaded from time to time on our website "www.fencingindia.org" of the Fencing Association of India. On the day of the SGM, Returning Officer took up the election process as per the agenda and announced the results of the election and declared the following persons as elected:
 - 1) Shri Satej Dnyandeo Patil as President.
 - 2) Shri Manu Kapila as Executive Member.

6. The RO also furnished his report alongwith the records of the election to FAI.

Returning Officer's Report

Fencing Association of India (FAI) requested me, vide letter dated 31.08.2022, to conduct the election for the vacant posts of their body, in accordance with the model election guidelines of the Government and FAI Constitution, which had arisen due to resignation etc in the Special General Body Meeting on 18.09.2022 necessitating election to the vacant posts for the remainder period of the term i.e. 2021-25. After going through the documents attached with the request such as the election notice, model election guidelines of the Government and FAI MoA. Upon my consent on 1.9.2022 to be the Returning Officer to conduct the elections, FAI issued the notification to appointment me as RO and provided the relevant documents including the electoral college. On 3.09.2022, I notified the election schedule with the following timelines for election to the post of President and one post of Executive Body Member:


- 2. During the period for filing of nominations, the following nominations were received for the vacant posts:
- 1) Sh. Satej Dnyandco Patil for the post of President.
- 2) Sh. Manu Kapila for the post of Executive Member.
- 3. The list of nominated candidates was published on FAI website and my office as per the schedule. The scrutiny of nominations was carried out on the scheduled date and the list of valid nominations was also published. During the prescribed time for withdrawal of nominations, no request for withdrawal was received. The list of contesting candidates was published in Form 6 on 13.09.2022.
- 4. On the scheduled day of the election i.e. on 18.9.2022, the SGM commenced at the scheduled venue at Hotel The Suryaa, New Friends Colony, New Delhi and after completion of the proceedings of agenda 1, the election listed as Agenda number 2 was taken up by me. The house was informed that all the protocol for COVID-19 has to be followed by one and all and only such persons whose names appear in the electoral college shall remain present in the house and others may leave till the election process was over. I informed the authorised representatives present in the house about the detailed process followed in the entire process of the conduct of the elections. They were informed that only one nomination each for each of the vacant posts were received. Those were found to be valid and there were no withdrawals. Since there was not more than one candidate for each post, voting is not necessary and the candidates stand elected unopposed. I announced in the house that Shri Satej Dnyandeo Patil and Shri Manu Kapila are elected as President and Executive Body Member respectively. The result sheet in Form-15 was signed by me in the presence of the IOA Observer which was also shown to the house.
- 5. I congratulated the newly elected office bearers and wished them good luck. Since the remaining agenda of the SGM was not relating to election, I handed over the dais and left the venue. Since the election process was completed I herewith enclose all the documents of the election for your information and records.
