# Revised Notification of Selection Trials for the Senior Asian Championships, Senior World Championships and Asian Games

With reference to the above-mentioned subject, the Fencing Association of India (FAI) is issuing this revised notification on conducting the Selection Trials for the Indian Fencing Team (Women and Men) to participate in the upcoming international competitions listed below:

♦ Senior Asian Fencing Championships: 17<sup>th</sup> Jun – 22<sup>nd</sup> Jun, 2023 in Wuxi, China

♦ Senior World Fencing Championships: 22<sup>nd</sup> Jul – 30<sup>th</sup> Jul, 2023 in Milan, Italy

♦ Asian Games: 23<sup>rd</sup> Sept – 8<sup>th</sup> Oct, 2023 in Hangzhou, China

The Selection Trials will be held on 5<sup>th</sup> June 2023 in New Delhi from 9:00 am to 5:00 pm. The time of reporting is 8.15 am. The venue will be informed later.

#### 2. FOR SPECIAL PERMISSION ON DUTY/ LEAVE

2.1. The Annexure details the information on the education/ employment of the fencers. The Selection Trials is critical in representing India in the above-mentioned international competitions.

The Fencing Association of India requests the Educational Institutions and Employers mentioned therein to please grant the fencers special permission on duty /leave for attending the Selection Trials. The days/time of travel and visa process may also be considered in processing the permissions.

#### 3. CONDITIONS

3.1. As the Indian Olympic Association has set June 2023 as the last date of entry by name for the Asian Games, it is combined Selection Trials for three competitions and there will be no

exemption for any fencer that does not participate in the Selection Trials. Any change in the entry for a competition hereafter would be only on grounds of medical injury, disciplinary sanctions, or other unavoidable circumstances, as per the replacement policy of the governing body/ organiser.

3.2. All fencers participating in the Selection Trials are required to submit a Medical Certificate, in the template shared with this letter, on or before **31**<sup>st</sup> **May 2023**, to - <a href="mailto:entries.fai@gmail.com">entries.fai@gmail.com</a>. As there is a few months gap between this and the Asian Games, there are chances that information/ certificates might be collected again.

As for a brief survey of mental or psychological status on page 3 of the template, the WHO (Five) Well-Being Index (Attachment), a simple standardized 5-item rating scale or Baron Depression Screener for Athletes (Attachment Page 673 in the IOC consensus statement) could be used. This test may be supplemented, if required, by a standard mental status examination by a resident or consultant Psychologist/ Sports Psychologist in the same Hospital.

- 3.3. Fencers have to make their own arrangements for boarding, lodging, and transportation.
- 3.4. Each participant must assure of their responsibility for accident/illness/ mishappening, etc., and health/ medical insurance as well as civil liabilities during the Trials/ visit.
- 3.5. As a reply to the ACTC plan 2023 2024 is still awaited, in case the Government of India/ Sports Authority of India does not approve the Senior Asian Fencing Championships and Senior World Fencing Championships at Government cost, the selected fencers must bear the expense for their participation, for which an undertaking is to be submitted to the Fencing Association of India at the venue, before participating in the Trials.
- 3.6. Chinese Visa As known, the visa process is time-consuming. Generally, a visa has to be applied for at the centre that is close to the registered address. We do not want these glitches to impact the participation of fencers in the Senior Asian Fencing Championships. It is critical to ensure that any fencer selected on the 5<sup>th</sup> of June has equal access to avail the visa. Accordingly, FAI has commenced the visa process.
  - Wuxi Asian Fencing Championships Committee is extending invitations to all in the shortlist.
  - UNIGLOBE Koniva Tours & Travel is processing the visa application of fencers in the shortlist and getting an appointment for Pan-India submission and biometrics at the Chinese Visa Application Center in New Delhi, on 6<sup>th</sup> June 2023.

For facilitating the same, the Agency requires the following:

- a. A duly completed Chinese visa application. A template is shared with the letter.
