I am directed to convey the approval of competent authority towards financial assistance for holding of Senior National Coaching Camp in preparation of Asian Games 2023. - Medical expenditure on actual basis, provided the said injury is not covered under Insurance. However, Regional Centre may incur the expenditure immediately and claimed the same amount from Insurance agency. Subsequently a separate record be maintained in such cases by the concerned Regional Centre.
- 2. List of campers reported for the camp should be forwarded to the TOPS Division immediately after 03<sup>rd</sup> day from the commencement of the camp.
- 3. Regional centre will make necessary arrangements for facial attendance of the Campers at the camp venue.
- 4. Any inclusion/deletion of National Coaching Campers should not be entertained without prior approval of the TOPS Division.
- 5. On conclusion of the Coaching Camp RC, Mumbai shall submit a report on coaching camp within 10 days to the TOPS Division, New Delhi. The record of daily attendance is to be maintained by the Chief Coach/Coach and shall be provided by RC, Mumbai at the time of conclusion of the camp.
- 6. RC, Mumbai will make the necessary arrangements as per the approved norms in the above-mentioned table of financial implications for the smooth conduct of the NCC.
- 7. The Expenditure may be debited under the head of Scheme of "Assistance to NSF" budget head 49.0000 and Sub-Heads 49.0501.
- 8. The RC, Mumbai should submit the monthly expenditure statement discipline wise and head wise on the last working day of the month and utilization certificate within 15 days after completion of the camp to the TOPS Division.
- 9. Furthermore, Army Sports Institute, Pune to make all the necessary arrangements as per approved norms/approved by Competent Authority, for the camp sanctioned. The Bills/Account of the camp will be settled by Regional Centre on receipt of expenditure statement along with utilization certificates in the prescribed form GFR-2017 (form 12-A) duly certified by Chartered Accountant firm empanelled with CAG and counter signed by authorized signatory of the concerned Chief Coach of the camp.
