1. INTRODUCTION

The Fencing Association of India (FAI) is the governing body of fencing in India. As an affiliated member of the International Fencing Federation (FIE), Fencing Confederation of Asia (FCA) and Commonwealth Fencing Federation (CFF), the FAI administers various aspects of sports governance and welfare of the fencers in the country. The FAI manages the representation of fencers participating in the Olympic Games, Asian Games and competitions of the FIE, FCA and CFF.

The cost of preparing the proposal and participating in the pitch including any visit to the FAI's office are not reimbursable as a direct cost of the assignment. FAI is not bound to accept any of the proposals submitted.

FAl's employees, committee members, board members and their relatives (spouse and children) are not eligible to participate in this tender.

At any time before the deadline for submission of the proposals, FAI for any reason; either at its own initiative or in response to clarification requested by an intended bidder, may amend the requirements of submission. Any such amendment shall be issued in writing or sent by email to agencies that submitted the bid in advance, and such amendments will be binding on all. FAI may at its discretion extend the deadline for the submission of the proposals. FAI reserves the right to cancel the tender, if such a situation comes up.

Throughout the bidding documents, the terms 'Bid' and 'Tender' and their derivatives (Bidder, Bidders, Bid/ Tender, Bidding/ Tendering, etc.) are synonymous.

Submit mandatory documents - Copy of GST Registration Certificate and PAN Card.

The proposals shall be in English language.

The proposal shall include financials for implementing the scope of work, above-mentioned, for the Asmita Women's Fencing Leauge 24-25, covering all costs and charges involved.
