1. To consider & adopt the minutes of Annual General Body Meeting for the year 2022-23 held on 30.12.2023 at Raipur (C.G.).
2. To consider & adopt Annual Report of the Secretary General, FAI for the year 2023-24 & 2024-25.
3. To consider & adopt the audited accounts of FAI for the year 2023-24 & 2024-25.
4. To consider and approve the estimated budget for the financial year 2024-25 & 2025-26.

The election of the Fencing Association of India is due in August 2025, which we have to complete in the month of August, but the National Sports Governance Bill 2025 (commonly known as the "Sports Code 2025") was introduced in the Lok Sabha on July 23, 2025. However, it is important to note that it is yet to be passed by both houses of Parliament and receive the President's assent to become a law. In view of the above facts, it is proposed to hold the election of the Fencing Association of India for the year 2025-29 within one month of the implementation of "Sports Code 2025" by the Government of India. In this regard, we want your opinion on "Sports Code 2025" to be implemented or not or go by "National Sports Development Bill 2011".

  - Telangana fencing Association, Telangana,
  - Fencing Association of Andhra Pradesh, Andhra Pradesh
  - J & K fencing Association, Jammu & Kashmir
9. Fencing Association of India is going to host Asian Cadet Cup in September 2025 in Haldwani Uttarakhand from 19<sup>th</sup> September to 22<sup>nd</sup> September 2025. We will proceed with elections in the month of November.
