Revised Notification- Final Selection Trials for Senior Indian Team

With reference to the notification FAI/2026-27/89/190; dated 29th May 2026 The Fencing Association of India (FAI) will be conducting the final Phase of the Selection Trials to select the Senior team to participate in the upcoming **Asian Senior Championship, World Senior Championship, and the Asian Games 2026** and upcoming FIE competitions.

1) Dates of the Trials:

Date	Weapon	Category
03 June 2026	Epee	Men & Women
04 June 2026	Foil	Men & Women
05 June 2026	Sabre	Men & Women

2) Venue: NSNIS Patiala

Note* - Participation in the trials is a must to be considered for the competitions

4) Format of the trials:

- 4.1 One Poule (pool) round of 5 touches. Fencers will be put in One pool to fence each other. The rankings after the Poule round will be used to formulate the DE table
- 4.2 Followed by the Direct Elimination round (15 touches).
- 4.3 A direct elimination bout for the determination of 3rd place shall be conducted.

5) Selection of Fencers:

- 5.1 Selection of the Fencers for the above-mentioned competitions will be based on: The top four (4) fencers, based on the ranking points of the Selection Trials 1 (27th to 29th April 2026) and Final Selection Trials (3rd to 5th June 2026) and the criteria specified by FAI in previous notifications.
- 5.2 In the event of a tie in ranking points:
In-case the points are same, the fencer achieving the higher placing in either Selection Trial 1 or Selection Trial 2 shall be ranked higher.



In-case, the points and rankings are identical, the fencer achieving the higher rank in the Final Selection trial (latest) will be ranked higher.

5.3 The decision of the Selection Committee shall be final and binding on all participants.

*Note: The fencers participating in the Selection Trials will have to submit an undertaking. The undertaking form will be shared separately. Fencers who do not submit the undertaking shall not be allowed to participate in the trials.
